The Promoter has secured a clean, safe, and well-lit venue for the promotion and display of wedding attire, bridal services, and related products. The Exhibitor agrees to participate under the following terms and conditions.

1. Booth Space & Setup

- Booth spaces are approximately **8’ x 10’**. With black pipe and Drape
- Exhibitors must provide their own decorative backdrops and décor.
- Promoter will provide **one table, one linen, and up to two chairs**.
- Electrical access is available for an additional **\$40**.

2. Fees & Payment

- The per booth fee of \$450 is **non-refundable** and due in full at the time of contract signing.
- Checks should be made payable to **Venue Chisca**.

3. Load-In, Event Hours & Load-Out

- **Load-In:** Jan 10th from 8am to 12pm
- Exhibitors must be fully set up and ready before doors open at 1pm.
- Exhibitors must remain open and staffed for the duration of the event.
- **Load-Out:** Immediately following the event; all items must be removed by 5:30 PM.

4. Display & Safety Requirements

- All decorative materials must be **flame-retardant**.
 - Electrical wiring must comply with **National Electrical Code standards**.
 - Food Exhibitors must comply with all **PCHD rules and regulations**.
 - The Promoter reserves the right to remove any exhibit not in compliance, without refund.

5. Restrictions & Conduct

- Booth space may not be assigned, sublet, or shared without written approval.
 - No loud, disruptive, odor-producing, or inappropriate displays are permitted.
 - Air-operated equipment is prohibited.
 - Aisles may not be used for demonstrations or displays.
 - No materials may be attached to walls or venue property without permission.
 - Exhibitors may only promote their own business and may not distribute materials for non-participating businesses.
 - No outside décor companies may be advertised.
 - Violations may result in removal without refund.

6. Liability & Indemnification

The Promoter, Venue Chisca, the Peoria Marriott Pere Marquette, and their employees are not responsible for loss, theft, damage, injury, or delays due to any cause. Exhibitors agree to indemnify and hold harmless all parties from any claims arising from participation in the event.

The Promoter is not responsible for attendance levels due to weather, competing events, or circumstances beyond its control. The Promoter reserves the right to relocate the event if necessary.
